Glideaway warrants to the original consumer purchaser that the KD foundation you purchased is free from defects in workmanship and material. This Limited Warranty lasts for three years following the date of purchase. This Limited Warranty is not transferable and coverage terminates if the original consumer purchaser sells or otherwise transfers the product. Glideaway reserves the right to decide the appropriate solution. For product for commercial use, please refer to paragraph V.

If you wish to make a claim

You must contact the Glideaway dealer from whom the product was purchased, or if not available, Glideaway within fifteen (15) days of discovery of the problem with the original sale receipt which identifies the date of purchase.

What we will do

First year of purchase. If the defect occurs within the first year of purchase, we will repair or replace at our discretion and without charge the defective KD foundation.

Second through third year of purchase. If the defect occurs in the second through third year following purchase, we will attempt to repair the defective KD foundation. If the KD foundation needs to be replaced, you will be responsible for all related charges not to exceed the current KD foundation price minus a credit for the remaining prorated value of the KD foundation (33 1/3% of the current KD foundation price for each year remaining on the three year limited warranty). If the covered KD foundation is no longer available, we will choose a comparable KD foundation and the same prorated formula will be used.

This limited warranty does not cover or apply to:

- I. Product which has been cut, soiled, torn or damaged due to misuse, abuse or accident;
- II. Consequential damages including but not restricted to damage to persons or property other than the product itself;
- III. Damage caused by animal beaks, teeth or claws;
- IV. Incidental damages such as loss of time, loss of use and rental charges, and;
- V. KD foundations used in commercial type settings, such as but not limited to dormitories, hotels and rentals. KD foundations used in commercial type settings are warranted to the original purchaser against manufacturing defects for up to ninety (90) days from the date of purchase.
