GLIDEAWAY MATTRESS FOUNDATION THREE YEAR LIMITED WARRANTY

Glideaway warrants to the original consumer purchaser that the mattress foundation you purchased is free from defects in workmanship and material. This Limited Warranty lasts for three years following the date of purchase. This Limited Warranty is not transferable and coverage terminates if the original consumer purchaser sells or otherwise transfers the product. For product for commercial use, please refer to paragraph V.

If you wish to make a claim

You must contact the Glideaway dealer from whom the product was purchased, or if not available, Glideaway within thirty (30) days of discovery of the problem with the original sale receipt which identifies the date of purchase.

What we will do

First year of purchase. If the defect occurs within the first year of purchase, we will repair or replace at our option and without charge the defective mattress foundation.

Second through third year of purchase. If the defect occurs in the second through third year following purchase, we will attempt to repair the defective covered mattress foundation. If the mattress foundation needs to be replaced, you will be responsible for all related charges not to exceed the current mattress foundation price minus a credit for the remaining prorated value of the mattress foundation (33 1/3% of the current mattress foundation price for each year remaining on the three year limited warranty). If the covered mattress foundation is no longer available, we will choose a comparable mattress foundation and the same prorated formula will be used.

This limited warranty does not cover or apply to:

- I. Mattress foundations that are not appropriately supported by bed frames and mattress foundations that are placed under queen and larger sized mattresses that are not supported by an appropriate center support.
- II. Product which has been cut, soiled, torn or damaged due to misuse, abuse or accident;
- III. Consequential damages including but not restricted to damage to persons or property other than the product itself;
- IV. Incidental damages such as loss of time, loss of use and rental charges, and;
- V. Mattress foundations used in commercial type settings, such as but not limited to dormitories, hotels and rentals. Mattress foundations used in commercial type settings are warranted to the original purchaser against manufacturing defects for up to ninety (90) days from the date of purchase.
