For product for commercial use, please refer to paragraph VII.

IF YOU WISH TO MAKE A CLAIM:

You must contact the Glideaway dealer from whom the product was purchased, or if not available, Glideaway within fifteen (15) days of discovery of the problem with the original sale receipt which identifies the date of purchase.

If the defect occurs within the first year of purchase, we will repair or replace at our option and without charge the defective upholstered headboard.

- I. Damage occurring from weight bearing pushing or pulling.
- II. Product which has been cut, soiled, torn or damaged due to misuse, abuse or accident;
- III. Consequential damages including but not restricted to damage to persons or property other than the product itself;
- IV. Stains caused by grease, inks, cosmetics, bleach, alcohol, dyes, solvents, corrosives or bodily fluids;
- V. Damage caused by animal beaks, teeth or claws;
- VI. Incidental damages such as loss of time, loss of use and rental charges, and;
- VII. Upholstered headboards used in commercial type settings, such as but not limited to dormitories, hotels and rentals. Upholstered headboards used in commercial type settings are warranted to the original purchaser against manufacturing defects for up to ninety (90) days from the date of purchase.
